1. What The Commonwealth Public Trust Is

The Commonwealth Public Trust is the **lawful structure** through which:

- the People reclaim their standing,
- the Crown is restored to its rightful place,
- the Constitution is revived in its Imperial force, and
- lawful government can operate once again.

It is not political.

It is not corporate.

It is not ideological.

It is a **trust**, grounded in:

- **Natural Law**
- **English Common Law**
- **Imperial Constitutional Law**
- **Trust Law and Equity**
- **Maxims of Law**

A trust **cannot be dissolved** by corporate legislation.

A trust **stands where the People stand**.

2. When The People Created The Commonwealth

On 1 January 1901, the People — through referendum and consent — became **Settlers of a national trust**:

- They created the Commonwealth.
- They vested authority in the Crown under the Constitution.
- They established public offices as trustees.

This structure was and remains:

- lawful
- binding
- superior to corporate governance
- beyond the reach of private or foreign interests

The corporate system did not replace the Commonwealth — it simply offered an **alternative** and led the People into it by presumption and silence.

3. What Happened After 1973

Through administrative reform, corporate policy, and statutory reconstruction, a **parallel system** emerged:

- corporate government corporations
- corporate courts
- corporate identities
- corporate “States”

- corporate finance and taxation structures

None of these replaced the Commonwealth.

They operate **only by consent, presumption, and participation.**

The Commonwealth Public Trust re-establishes the lawful system.

4. The Public Trust Restores Lawful Standing

A man or woman must stand as:

- **the living,**
- **in natural allegiance,**
- **under God,**
- **under the Crown,**
- **under the Imperial Constitution,**
- **and not as the PERSON.**

The Public Trust provides the mechanism to:

- rebut presumption
- restore identity
- record nationality
- establish jurisdiction
- assert standing
- operate lawfully

It allows the living man or woman to return to their rightful place **above the corporate PERSON**, not inside it.

5. IDENTITY: THE CORE OF ALL JURISDICTION

The corporate system recognises only:

- **PERSONS,**
- **Subjects of the State,**
- **Consumers,**
- **Clients,**
- **“Humans”** (in the neo-Roman civil sense).

It does **not** recognise:

- the living soul
- the Commonwealth National
- the natural-born inheritor
- the man or woman in natural allegiance

The Commonwealth Public Trust restores identity under:

- the Creator
- Natural Law
- English Common Law

- the Crown
- the Imperial Constitution

Identity → Standing → Jurisdiction → Remedy.

6. THE TRUST STRUCTURE

The Commonwealth Public Trust is structured as follows:

- **Settlor:** The People and their original constitutional act
- **Protector:** The Crown in Right of the Commonwealth
- **Trust Instrument:** The Commonwealth of Australia Constitution Act 1900 (Imperial)
- **Trustees:** Commonwealth Trustees & Board of Stewards
- **Beneficiaries:** The living men and women of the Commonwealth
- **Jurisdiction:** Natural Law + Common Law + Imperial Constitutional Law
- **Purpose:** Peace, order, good government, protection of rights, restoration of lawful governance

A trust is enforceable **only in law and equity**, not corporate statute.

7. What The Public Trust Provides

✓ Restoration of Lawful Identity

Recognised as a **Commonwealth National**, not a corporate PERSON.

✓ Restored Jurisdiction

You now stand under the highest lawful authorities.

✓ Restored Right to Inherit

Only the living can inherit land in Fee Simple Absolute.

✓ Lawful Electoral Roll

Re-establishing the People as the source of all lawful power.

✓ Lawful Public Offices Reopened

Including Commonwealth Justice of the Peace.

✓ Protection of Estate & Rights

Property, rights, and standing restored under the lawful Constitution.

8. What The Public Trust Does **Not** Do

It does **not**:

- attack the corporate system
- overthrow anything
- engage in politics
- promote conflict
- interfere with private contracts

- operate under ideology
- create a new government

Instead, it simply **revives** the lawful structure that already existed — the one created by the People, blessed by God, and executed under the Crown.

9. A Peaceful, Lawful, Rightful Restoration

The Commonwealth Public Trust stands on three pillars:

1. Peaceful

No conflict, no rebellion, no opposition.

The lawful path avoids the corporate battlefield.

2. Lawful

Grounded in the highest authorities:

Divine Law → Natural Law → Common Law → Imperial Law.

3. Rightful
