- 4. That I do hereby refute, deny, and condemn any inference, presumption, assumption, or entrapment that I am, or have ever been, an informed and considered voluntary Participant, Citizen, Ward, or Surety of any corporate political society styled or referred to as the United Nations Member State such as "AUSTRALIA"; and
- 5. That henceforth I revoke and annul any affirmation, oath, contract, pledge, vow, or presumed allegiance whether entered into knowingly or unknowingly and particularly any such supposed contracts lacking full disclosure, meeting of the minds, or lawful consideration, save only for that Allegiance lawfully owed and affirmed herein.
