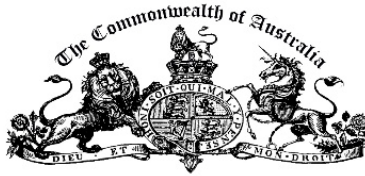

Statutory Declaration**

Made pursuant to the Statutory Declarations Act 1911 (Imperial) 1 & 2 Geo. 5. c. 6

Whereas I, the Subscriber hereto, being the Declarant, a living soul of sound mind and of mature age, do solemnly and sincerely declare as follows:

This Declaration serves solely to correct the Public Record and to place upon that Record my lawful standing and allegiance, where the same was previously mischaracterised, presumed, or recorded under a corporate political or statutory construct, and to record my standing under The Commonwealth of Australia for lawful recognition and protection under The Crown in Right of The Commonwealth of Australia, and for my eligibility to be entered and recorded upon the Commonwealth Electoral Roll as a National of the Original Commonwealth; and

This Declaration records standing arising by correction, conscious choice, and lawful allegiance, and does not create, confer, or presume any civil, political, corporate, or statutory status beyond that which lawfully arises thereby; and

1. Jurisdiction

I do hereby declare that I am subject first to Divine and Natural Law, and thereafter only to English Common Law, Imperial law, and equity, and to the lawful jurisdiction of The Commonwealth of Australia under the Commonwealth of Australia Constitution Act 1900 (Imperial); and

2. Correction of Prior Status

I declare that I was previously mischaracterised, recorded, or treated as an Australian citizen or participant within a corporate political society, such status having arisen without full disclosure, without informed consent, without lawful consideration, or without a meeting of the minds; or, alternatively, that I was born in, or originate from, a non-Commonwealth country and have never knowingly sworn a citizenship oath to Australia or to any Commonwealth realm; and

That upon becoming fully informed as to the lawful distinction between corporate citizenship and national standing under The Commonwealth, I have lawfully withdrawn from, revoked, and corrected any such corporate status where it existed; and

3. Allegiance and Constitutional Affirmation

That I have, by my own free will and informed consent, previously made a Constitutional Affirmation of Allegiance pursuant to the Schedule to the Commonwealth of Australia Constitution Act 1900 (Imperial), by a separate Nationalisation Affirmation of Allegiance, and that the same is hereby acknowledged and placed upon the Public Record for the purposes of Electoral Roll enrolment; and

4. Standing under The Crown

That by Divine and Natural Right, and by virtue of my lawful correction of status and Constitutional Affirmation, I possess lawful standing as a British Subject under the British Commonwealth, and, being domiciled within The Commonwealth of Australia, standing also under The Crown in Right thereof within The Commonwealth of Australia; and therefore stand as a National and British Subject, with all rights, duties, and protections appertaining thereto; and

5. Refutation of Corporate Presumptions

That I do hereby refute, deny, and condemn any inference, presumption, assumption, or entrapment that I am, or have ever been, an informed and considered voluntary participant, citizen, ward, or surety of any corporate political society, including any entity styled or referred to as a "United Nations Member State," such as the corporate entity known as "AUSTRALIA"; and

6. Revocation of Unlawful Allegiances

That henceforth I revoke and annul any affirmation, oath, contract, pledge, vow, or presumed allegiance — whether entered into knowingly or unknowingly — particularly any such instrument lacking full disclosure, lawful consideration, or a meeting of the minds, save only for the Allegiance lawfully affirmed herein by correction and Constitutional Affirmation, and my duty to God.

Understanding and Truth

This Understanding and Statement of Truth forms part of this Statutory Declaration and Commonwealth Electoral Roll Enrolment, and shall be read as one instrument holding equal force and effect in law, equity, and conscience.

The Declarant affirms that they have read, or have had read to them, the contents hereof; that they are of sound mind and lawful capacity; that they understand the nature, meaning, and effect of what is being declared; and that this Declaration is made freely, voluntarily, without coercion, and in good faith and honour, in accordance with the Laws of the English Imperial Realm, as a living man or woman within The Commonwealth.

Declaration and Reservation of Rights

I hereby declare and give notice that, by virtue of my lawful standing and Allegiance affirmed herein, I retain, reserve, and enjoy all natural, civil, constitutional, and common-law rights, liberties, protections, capacities, and immunities appertaining to me as a living man or woman under The Crown.

Without limiting the generality of the foregoing, such rights include the right to life, liberty, property, lawful protection, due process, freedom of conscience, freedom of movement, and the peaceful use and enjoyment of my estate, labour, and affairs, according to law.

I affirm that these rights arise by nativity, domicile, and allegiance, are not granted by statute or administrative act, and are exercised in peace, good faith, and honour, subject only to Divine Law, Natural Law, and the lawful Constitution and laws of The Commonwealth.

Nothing in this Declaration shall be construed as a claim to authority over others, nor as an assertion of any right exercised contrary to law, but only as a declaration and reservation of rights lawfully appertaining to me and placed upon the Public Record.

Attestation for the Public Record

And I make this solemn Declaration and Affirmation of Allegiance conscientiously believing the same to be true, and by virtue of the Statutory Declarations Act 1911 (Imperial); and in witness of my living standing, I here set my autograph as a living soul in red ink, signifying life, with my thumbprint affixed thereon, and I affirm that the living likeness affixed hereto is a true and faithful representation of my physical form.
