



Solemn League and Covenant of the People of the Commonwealth of Australia

Parchment Edition — For Public Endorsement and Lawful Record

PREAMBLE:

In the spirit of the Scottish National Covenant (1638), the Scottish Solemn League and Covenant (1643), the Ulster Solemn League and Covenant (1912), and by the supreme lawful authority of the Commonwealth of Australia Constitution Act 1900 (Imp.), as proclaimed and gazetted on the first day of the first month, nineteen hundred and one, under the Royal Coat of Arms.

WHEREAS, the people of the Commonwealth of Australia stand in the tradition of life, liberty, the pursuit of happiness, and lawful governance with God in our hearts. Our duty as the rightful sovereign heirs of this Nation is to refuse to recognise unlawful Parliament by defending constitutional integrity. We, the people of the Commonwealth do solemnly affirm and hereby Decree and Declare the following:

I. Sovereignty Rests with the People. The Commonwealth of Australia Constitution Act 1900 (Imp.), as proclaimed under the Royal Coat of Arms, is the supreme law of the land. Ultimate authority is enshrined in the people. Any government or institution that departs from this Constitution acts without lawful authority.

II. Breaches of Law and Trust by Government. The Parliament has usurped its authority. Peace, order, and good government replaced by conspirators sabotaging our Nation. Such acts constitute breaches of fiduciary duty and a forfeiture of its role as servant, agent, administrator and trustee of the Commonwealth. The Parliament has:

- Failed to bear the constitutional oath of true allegiance prescribed at s42.
- Reconstituted itself as a foreign corporate entity without enumerated head of power.
- Enacted legislation beyond the limits of State and Commonwealth authority under s51.
- Entered into unlawful treaties and obligations absent loyalty, law or the Will of the people.
- Engaged in coercive mandates, surveillance, censorship, and violation of privacy—ultra vires.
- Failed to loyally serve the people and transferred wealth to foreign interests.
- Committed fraud, theft, and treason, undermining the common weal acting against the people.

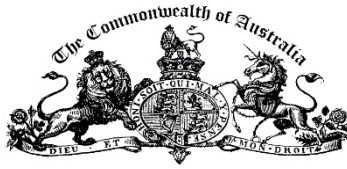
III. Reclaiming Our Lawful Role. The people of the Commonwealth of Australia, as sole and rightful beneficiaries by inherent Right of the Commonwealth, by signing this Covenant, by Decree, We Declare:

- Parliament as appointed Servants, Agents, Administrators and Trustees of the Commonwealth, have failed to comply with Chapters I, II, and III of the Constitution, therefore have breached their trust.
- We, the people, now lawfully reclaim our inheritance.
- We assert our sovereign rights as the supreme, absolute, irrevocable authority, and beneficiaries of the Commonwealth.
- The people's duty is to guard our inheritance and ensure Just governance for all future generations.

IV. Lawful Constitutional Redress. We pursue redress by lawful means:

- Through constitutional challenge and lawful courts of competent jurisdiction under the Commonwealth;
- Through lawful repeal of all unlawful statutes and nullification of unconstitutional treaties;
- Through lawful assertion of our rights as the true sovereign beneficiaries.

The High Court of Australia: Bound to the Constitution established under Chapter III of our Constitution as the supreme Court of the Nation, recognised as the lawful guardian of the Constitutions. All people of the Commonwealth may seek redress in this Court, duty-bound to protect the sovereignty of the People and the integrity of our constitutional framework. Its duties include:



- Upholding the Commonwealth of Australia Constitution Act as the supreme law;
- Ensuring all laws are within constitutional power (Section 71);
- Interpreting the Constitution in original jurisdiction (Sections 75 and 76);
- Striking down laws repugnant to constitutional limits, preventing violation of the Constitution;
- Acting as the Nations final Court of Appeal to guard against abuse of power;
- To prevent encroachment by Federal Parliament upon the States or the States upon Federal Parliament.

¶. National Sovereignty and Self-Reliance. By Decree, We Declare:

- Re-establishment of a Commonwealth-owned public bank;
- Restoration of lawful Parliament and national industry;
- Rejection of all foreign entanglements contrary to our sovereignty;
- Nullification ab initio of all unconstitutional agreements.

¶¶. Declaration and Decree of the People's Authority. We, the people, are the Commonwealth. We are the Power. The Crown is our head of authority. We are the true lawful stewards of this land. We act not by permission but by inheritance. We do not recognise the corporate Parliament as lawful. From this day forward:

- Unconstitutional actions, acts, legislature, statutes and laws are void;
- Office holders must bear true allegiance in accordance with the Constitution;
- Commonwealth wealth and resources belong to the Commonwealth, this is Our Claim of Right;
- Actions taken will be peaceful, just, and founded in law.

¶¶¶. Call to Action. To all Australians of **Honour** and **Conscience**: Read this Covenant. Endorse it in good faith, knowing it is necessary to defeat the present conspiracy of lawless and unconstitutional government. Stand lawfully and peacefully. Rebuild our institutions, restore our sovereignty, and protect future generations.

¶¶¶¶ Closing Declaration and Decree. With the blessing of Almighty God: From this day forth, by the Will of the people of the Commonwealth, by Decree, We declare: We are the Power and true Authority of the Nation by rightful succession. We seek justice, accountability, and restoration. This is our sacred Trust. This is Our Claim of Right. This is our lawful stand. Binding in Conscience, in History, and in Law. As our ancestors stood against tyranny, so now do we with steadfast hearts, bound by sacred duty and honour.
